Parade Rules



- Entry deadline is Thursday, December 4th, 2025, by 4 p.m.
- Only one (1) entry per company will be allowed without prior approval.
- To ensure the safety of those watching, **PLEASE DO NOT THROW** candy, beads, flyers, etc. from your entry. **However, you may have "crowd walkers" to hand these items out.**
- To qualify to be in the parade, your unit must CHECK IN at W. Liberty/N. Franklin streets between 5:00 p.m.-5:30 p.m. on Friday, December 5, 2025. You will be directed to your parade lineup spot on W. Liberty upon checking in.
- All entries must be decorated (**more than just a sign is required**) **and should include some type of music and lights.** If you do not have a decorated entry, you will not be able to participate. A minimum of **500 lights** are required for all non-equestrian and vintage car entries.
- A 5-pound ABC fire extinguisher is required for all motorized entries.
- Equestrian entries are required to arrange their own waste "scoopers" to follow their entries.
- No re-fueling of gas-powered generators after parade has begun.
- Adults must ride on/in any entry with children.
- Due to power lines, maximum allowable height for all entries is 14 feet.
- Any entry with a "live" Santa will be eliminated from the parade. The only Santa in the parade will be at the end of the parade with Mrs. Claus.
- Parade begins at 6 pm.
- Prizes for Parade winners are **Best in Show \$200, 1st Place \$100, 2nd Place \$75**

In case of inclement weather, the Christmas parade will be canceled (no reschedule date**) by noon Friday, December 6. Information will be posted at farmingtonregionalchamber.com and on Facebook.**
